Registration Fee: \*Current students are offered a discounted registration fee of \$35 per child (\$45 family) if registered by June 1<sup>st</sup>, 2024\*. A registration fee of \$40.00 per child (\$50 family) is required with registration form by July 1<sup>st</sup>, 2024. After July 1<sup>st</sup> the registration fee will be \$45.00 per child (\$60 family). This registration fee will secure your child's spot in class, as well as cover a digital copy of the 2025 spring recital performances for each family. Monthly payment is due on the first of each month. There is a discount payment schedule for those who have more than one student enrolled, those enrolled in more than one class, or those that pay in full for the year. A late fee of \$25 will be applied after the 10th of every month. A \$35 fee will be charged to all returned checks. All Families are required to keep a card on file. Monthly auto-pay customers will not be subject to the 3% convenience fee. Individual credit card tuition payments will be subject to the convenience fee. We accept cash, check, Venmo, Zelle, and auto draft payments without an additional fee. There are NO REFUNDS given for dancers that discontinue taking classes in the middle of a session or miss classes. There will be a total costume payment per class of \$100 due by December 1<sup>st</sup>, 2024. Payments can be made in full at the time of registration or in monthly installments due by December 1<sup>st</sup>, 2024. All costume payments are non-refundable. Tuition is non-refundable.
